European Week for Waste Reduction announces finalists of the EWWR Awards

On Friday, 24th of March 2017, the EWWR Awards Jury met in Brussels to determine the finalists and winners of the EWWR 2016 Awards. As every year, the most outstanding actions will be rewarded during the EWWR Awards Ceremony, which will take place in Barcelona this year.

The best Action Developers from the 2016 edition of the EWWR have been selected. On Friday, 24th of March 2017, the EWWR Awards Jury came together in Brussels to decide on the three finalists for each category of the EWWR Awards. The winners will be announced during the EWWR Awards Ceremony in Barcelona, Spain on 18th May 2017. The event will be part of the final **LIFE+ EWWR International Conference** entitled "[Qualitative prevention, a new approach to circular economy](#)".

The annual [EWWR Awards ceremony](#) is a festive moment created to reward the most outstanding actions carried out in each EWWR edition. The finalists and winners are decided by a Jury of European professionals working in the environmental sector. Hosted by [ACR+](#), the leading EWWR project partner, the Jury had a fruitful discussion about the fantastic actions submitted for the EWWR 2016 Awards. For all six categories of Action Developers, three actions have been chosen as finalists, according to the [selection criteria](#). Aspects such as visibility, the quality of the action proposed, or the lasting impact of the action have been taken into account for the selection process. It was not an easy task but finally the EWWR campaign from 2016 has its champions!

The EWWR 2016 Awards finalists

Out of the 86 actions that were submitted by EWWR Coordinators to run for the EWWR Awards, three actions per category of Action Developers have been chosen as finalists by the Jury. They are:
